TENTATIVE ORDER

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering the adoption of Settlement Agreement and Stipulation for Entry of Administrative Civil Liability Order (Stipulated Order) No. R9-2018-0178. The Stipulated Order is a settlement agreement between LPP Lane Field, LLC and the San Diego Water Board's Prosecution Team to address mandatory minimum penalties associated with alleged late reporting violations of General Waste Discharge Requirements for Groundwater Extraction Discharges to Surface Waters within the San Diego Region (Order No. R9-2015-0013).

To resolve the alleged violations without formal administrative proceedings, LPP Lane Field, LLC has agreed to the final imposition of an administrative civil liability in the amount of \$15,000, the mandatory minimum penalty amount required by Water Code section 13385.1.
