The California Regional Water Quality Control Board, San Diego Region (Regional Board), reviewed the following report:

2007 Water Quality Monitoring Report for Aliso Creek Outlet Maintenance Program Project

Based upon our review of your annual monitoring report, we observed the following violations of the Conditions of 401 Water Quality Certification No. 05C-009, Aliso Creek Outlet Maintenance Project Certification:

Finding: Condition C.1.a: The County of Orange shall submit monitoring results annually by March 1 of each year.

Violation: The Annual Monitoring Report was received late via e-mail on April 08, 2008.

Finding: Condition C.1.d: Water Quality Data shall be obtained by grab samples (except Secchi disc turbidity monitoring) and reported for:

• Turbidity: One semi-annual maintenance event shall be monitored every two years, and two routine berm-breaching events shall be monitored each calendar year.
