YOU ARE HEREBY NOTIFIED OF THE FOLLOWING ALLEGED VIOLATION:

Failure to comply with Directives A.1.and A.2. of Investigative Order No. R9-2008-0010:

BASIS FOR ALLEGED VIOLATION:

Directive A.1. of Order No. R9-2008-0010 directs you to submit a Workplan for Preliminary Site Assessment by May 30, 2008.


Directive A.2. of Order No. R9-2008-0010 directs you to submit a Preliminary Site Assessment Report by July 30, 2008.

To date, neither the Workplan nor the Report has been submitted.

The violation cited above is serious and may result in further enforcement action against you, including a civil liability being administratively implemented by the California Regional Water Quality Control Board, San Diego Region (Regional Board) under authority of section 13350 of the California Water Code. Any person failing or refusing to furnish information required under the authority of Water Code section 13267 or falsifying information submitted to the Regional Board pursuant to such a directive is guilty of a misdemeanor and may be subject to civil liability to \$1,000 per day of the violation.


