Violations of Order No. R9-2007-0227

Mr. Scott Frasco is hereby notified that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) reserves the right to take any enforcement action authorized by law for the violations described herein.

The Bianchi Family Trust is in violation of San Diego Water Board Investigative Order No. R9-2007-0227.

### A. Summary of Violation

Addendum No. 1, Directive 2 of Investigative Order No. R9-2007-0227 directs you to perform groundwater monitoring on groundwater monitoring wells MW1, MW9, and MW10 on a quarterly basis, and to submit a Groundwater Monitoring Report by 5:00 p.m. on October 30, 2010. A Groundwater Monitoring Report has not been submitted.

### **B. Summary of Potential Enforcement Options**

These violations may subject you to additional enforcement by the San Diego Water Board or State Water Resources Control Board, including a potential civil liability assessment of \$5,000 per day of violation (Water Code section 13268) and/or any of the following enforcement actions:

- administrative enforcement orders requiring you to cease and desist from violations, or to clean up waste and abate existing or threatened conditions of pollution or nuisance;
- 2. referral to the State Attorney General for injunctive relief; and
- 3. referral to the District Attorney for criminal prosecution.


