Failure to Comply With State Water Resources Control Board Order No. 2006-0003-DWQ, San Vicente Collection System

State Water Resources Control Board Order No. 2006-0003-DWQ

#### YOU ARE HEREBY NOTIFIED THAT:

The Ramona Municipal Water District (RMWD) is in violation of State Water Resources Control Board (State Water Board) Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems for failing to develop and self-certify a Sewer System Management Plan (SSMP) in compliance with the required time schedule for the San Vicente Collection System.

Such violations may subject you to further enforcement action by the State Water Board and California Regional Water Quality Control Board, San Diego Region (Regional Board), including administrative enforcement orders such as administrative civil liability in amounts of up to \$5,000 per day per violation; referral to the State Attorney General for injunctive relief; and, referral to the District Attorney for criminal prosecution.


### **Summary of Violations:**

### FAILURE TO DEVELOP AND CERTIFY SSMP

The RMWD failed to certify development of a written SSMP for the San Vicente Collection System in compliance with the provisions and time schedule required in Order No 2006-0003-DWQ.

1. Pursuant to Provision D.14: The Enrollee shall certify that the SSMP, and subparts thereof, are in compliance with the general waste discharge requirements of Order No. 2006-0003-DWQ by completing the certification portion of the Online Sanitary Sewer Overflow (SSO) database.

2. Pursuant to Provision D.15: The Enrollee shall comply with these requirements according to the time schedule in this section.

**Allegation:** The RMWD failed to complete and self-certify the following SSMP sections in the online SSO database by the due dates provided in Provision D.15:
