## SUBJECT: REVIEW OF MONITORING REPORTS FOR THE NORTH CITY WATER RECLAMATION PLANT

This letter is to notify the City of San Diego that in reviewing the June 2009–March 2010 monthly; April–June 2009, July–September 2009, October–December 2009, and January–March 2010 quarterly; and 2009 annual monitoring reports, the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) identified ten violations of Order No. 97-03. The following describes the violations:

The City of San Diego exceeded the 12-month average discharge specification for manganese, established at 50 micrograms per liter ( $\mu$ g/L), in June 2009, July 2009, August 2009, September 2009, October 2009, November 2009, December 2009, January 2010, February 2010, and March 2010 with reported values of 69, 68, 67, 65, 64, 66, 66, 68, 65, and 64  $\mu$ g/L respectively.

In addition to the violations cited above, the San Diego Water Board has the following comment regarding the submitted reports:

The column entitled, "Minimum Calculated CT, >450 mg-min/L" on the Recycled Water Chlorine Report is not clear. In the September 2009 monthly report, it appears that there were 4 days where the minimum CT dropped below 450 mg-min/L. Pursuant to Discharge Specification A.3 of Order No. 97-03, disinfection of recycled water shall be accomplished by a chlorine disinfection process that provides a CT value of not less than 450 mg-min/L **at all times**. In future monitoring reports please clarify the title of this column and include a column indicating the time the CT value is less than 450 mg-min/L. Each instance where the CT value drops below 450 mg-min/L is a violation of Discharge Specification A.3 of Order No. 97-03.
