The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) staff has reviewed the self-monitoring reports for the facility referenced above for the quarterly and annual reporting periods of April 2007 through December 2011. We have included the following violations below:

• Attachment E – Monitoring & Reporting Program (MRP) – Section X.B.2

- Annual Self-Monitoring Reports (SMRs) shall be due on August 1 for the preceding July 1 through June 30 year. The following annual reports were not submitted by the due date:
 - i. July 2006 June 2007, received September 5, 2007;
 - ii. July 2007 June 2008, received August 29, 2008;
 - iii. July 2008 June 2009, received September 2, 2009;
 - iv. July 2009 June 2010, received September 1, 2010;
 - v. July 2010 June 2011, received September 6, 2011.

Please take steps to ensure that the violations noted above do not occur in the future. Pursuant to the California Water Code (CWC), the violations noted are subject to additional enforcement action(s) by the San Diego Water Board including a time schedule order, cease and desist order, cleanup and abatement order, imposition of administrative civil liability, referral to the district attorney for criminal prosecution, or referral to the attorney general. Administrative civil liability amounts that may be imposed by the Regional Board under authority of CWC Section 13385 include up to \$10,000 per day, or up to \$10 per gallon for each gallon of waste discharged.
