Based upon our review of the information contained in the monitoring reports, the San Diego Water Board has included the following violations below:

• Attachment E – Monitoring & Reporting Program (MRP) – Section X.B.2

1. Quarterly Self-Monitoring Reports (SMRs) shall include non-storm water discharge visual observations. The October-December 2011 quarterly reports did not include the non-storm water discharge visual observations.

Please take steps to ensure that the violations noted above do not occur in the future. Pursuant to the California Water Code (CWC), the violations noted are subject to additional enforcement action(s) by the San Diego Water Board including a time schedule order, cease and desist order, cleanup and abatement order, imposition of administrative civil liability, referral to the district attorney for criminal prosecution, or referral to the attorney general. Administrative civil liability amounts that may be imposed by the San Diego Water Board under
