Subject: Monitoring Reports for Northern Regional Tertiary Treatment Plant

Mr. Entingh:

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has reviewed the July 2015 through September 2016 monthly monitoring reports, the April-June 2015, July-September 2015, and October-December 2015, January-March 2016, April-June 2016, July-September 2016 quarterly monitoring reports, and the 2015 annual monitoring report submitted by Camp Pendleton, in compliance with Order No. R9-2014-0006.

The San Diego Water Board has the following comments on the reports referenced above.

- 1. Monitoring and Reporting Program (MRP) No. R9-2014-0006 section II.A, requires the discharger to monitor pH on a weekly basis and report the results in the monthly monitoring report. However, pH was not sampled for the week of May 29, 2016 to June 4, 2016.
- 2. Future monitoring reports should clearly state if recycled water is being sent to reuse sites. This provides explanation to San Diego Water Board staff for missing data that would be required if recycled water was being used.

The next monitoring report required to be submitted is the October 2016 monthly monitoring report <u>due by December 1, 2016</u>.
