NOTICE OF PRE-HEARING CONFERENCE FOR Tentative Cleanup and Abatement Order No. R9-2005-0126

BACKGROUND

The staff of the San Diego Regional Water Quality Control Board (Regional Water Board) has issued Tentative Cleanup and Abatement Order No. R9-2005-0126, which establishes proposed cleanup requirements for San Diego Bay marine sediments located within and adjacent to the NASSCO and Southwest Marine shipyard leaseholds.

The Regional Water Board has determined that it is appropriate to separate the Board staff into a neutral advisory staff team and a cleanup staff team for the proceedings related to the Tentative Cleanup and Abatement Order, as explained in a memo dated June 30, 2005 that is available on the Regional Board's website

PRE-HEARING CONFERENCE

The Regional Water Board will hold a pre-hearing conference on September 26, 2005 at 9:00 AM at the San Diego Regional Board Office Board Meeting Room in San Diego. John Minan, Board Chairman, will be the presiding officer and conduct the pre-hearing conference on behalf of the Board. Representatives of all proposed designated parties (see below) and any other persons who seek designated party status are requested to attend. The pre-hearing conference will be open to the public, but only proposed designated parties and persons seeking designated party status will be permitted to participate. The goal of the pre-hearing conference is to ensure that the hearing(s) on the tentative Cleanup and Abatement Order proceed in an orderly and prompt manner. There will be no discussion of the merits of the tentative Cleanup and Abatement Order. To ensure an accurate record, the pre-hearing conference proceedings will be recorded on audio tape. Additional pre-hearing conferences may be scheduled if necessary.

DESIGNATED PARTIES FOR THE HEARING

California Environmental Protection Agency

Participants at a hearing are either "designated parties" or "interested persons." Parties to the hearing may present evidentiary testimony and are subject to cross-examination. Parties may also cross-examine other parties' witnesses. Interested persons may present non-evidentiary policy statements, but may not present evidentiary testimony. Interested persons are not subject to cross-examination and may not cross-examine parties.

* The San Diego Bay Council is a coalition of environmental organizations comprised of the San Diego Bay Keeper, the Environmental Health Coalition, San Diego County Surfrider Foundation, San Diego Audubon Society, and the San Diego Chapter of the Sierra Club.

Any other persons who wish to participate in the hearing as designated parties must request party status in writing. The written request must be submitted to Frank Melbourn at the above address and must be received no later than close of business on September 20, 2005. The request must explain the basis for party status, a general description of the evidence that will be presented, and the reason why the proposed designated parties to this hearing do not adequately represent the person's interests. Persons with similar interests are encouraged to request party status as a group.

GENERAL HEARING PROCEDURE

In addition to the specific procedures for the hearing that will be determined following the prehearing conference, the Regional Water Board will conduct the hearing in accordance with the regulations governing adjudicative proceedings of the State Water Resources Control Board and Regional Water Quality Control Boards. The following issues will be considered at this or subsequent pre-hearing conferences:

- **D** The Executive Officer's participation on the Advisory Team.
- □ The designation of parties.
- □ The specific procedures to be used for the hearing, as recommended by the Cleanup Team on July 14, 2005.
- □ A comprehensive list of contested issues of fact and law (note that this is an effort to identify the issues only; no discussion of the merits of the issues will be accepted).
- **□** The timing of submission of evidence and briefs.
- □ The length and date of the hearing.
- □ The location of the hearing.
- □ Participation by non-English speakers.
- □ The logistics for workshops, tours, and other methods for providing background information to the Board Members and the public.

Proposed designated parties and persons seeking party status are invited to submit comments or objections related to any of the above issues. If there are any other issues or objections that are appropriate for discussion during the pre-hearing conference, those issues or objections must also be raised for the Presiding Officer's consideration. All comments, issues, and objections must be received no later than the close of business on September 20, 2005. Comments, issues, or objections submitted after this date may not be considered, unless good cause for the delay is shown. Due to incomplete service and the nature and timing of the previous Regional Water Board agenda items related to this matter, all previously-submitted comments and objections must be resubmitted, or they will be deemed to have been waived.
