Wildomar identifies 29 acres as parks and recreation

Where did this number come from, city has 4 Public Park sites totaling 41.1 acres plus (one site consisting of 27 acres is undeveloped). 7.8 acres of Private or HOA parks for a total of 48.9 acres of parks and recreation land.

*These sites are **inspected on a frequency** detailed in the Permit and municipal-specific Jurisdictional Runoff Management Programs (JRMPs). Table 2 provides a list of potential pollutant source areas that may contain facilities and/or activities that generate pollutants within each Party's boundaries.*

The drainage system at Marna O'Brien Park is rarely inspected despite a written Water Quality Management Plan (WQMP) which contains a detailed schedule. The field drains, of which there are 7 are almost never clear of debris. The 2 parking lot drains which were to be filtered by 2 parking lot filters, these drains are never cleaned and the swale that is suppose to filter debris is nothing more than a dirt ditch devoid of vegetation. All of this along with the local trash company using the parking lot as a transfer station leads to Best Management Practices (BMP) being nil.

*2.2.2 Parks, Recreational and Open Space Areas As presented in Table 1, publicly owned parks and/or open space areas make up 55,416 acres (16%) of the Upper SMR WMA. Based on a review of available data, there are zero (0) parks in Menifee within the WMA, 89 in Murrieta, 61 in Temecula, **two (2) in Wildomar,***

This number is incorrect there are 2 public parks within the Santa Margarita Watershed ((one undeveloped consisting of 27 acres) (one developed public park consisting of 2.06 acres)). There are also 12 private or HOA parks consisting of 7.8 acres. There are 2 Public Parks consisting of 12.04 acres that flow into the San Jacinto

Watershed but are covered by the San Diego Regional Water Quality Control Board by Order No.R9-2015-0100.

*2.2.3 Landfills or Other Treatment Facilities for Municipal Waste There are three operating or **closed municipal landfills** or other treatment, storage or disposal facilities for municipal waste within the Parties' jurisdiction, located in City of Murrieta, City of Temecula, and the County of Riverside.*

Bundy Canyon Landfill Wildomar is a 83.87 acre closed facility (closed October 1953) that is close to the border of the two watersheds, Santa Margarita and San Jacinto, but clearly in the Santa Margarita Watershed per the Sedco Master Drainage Plan map of 1982.
