The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering a Basin Plan amendment to incorporate a Sediment Total Maximum Daily Load (TMDL) for Los Peñasquitos Lagoon. This action is being proposed to meet requirements of section 303(d) of the federal Clean Water Act. The Basin Plan amendment process is authorized under section 13240 of the California Water Code.

##### FILING OF ENVIRONMENTAL DOCUMENTS

The San Diego Water Board is proposing to adopt or amend the proposed Basin Plan amendment in accordance with a certified regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare environmental impact report under the California Environmental Quality Act (CEQA) [Public Resources Code section 21000 *et seq.*] and with other applicable laws and regulations.

##### PUBLIC HEARING

The San Diego Water Board will hold a public hearing on May 9, 2012 to deliberate and consider adoption of the proposed Basin Plan amendment to incorporate a Sediment TMDL for Los Peñasquitos Lagoon. The meeting will begin at 9:00 a.m.

##### REQUEST FOR PUBLIC COMMENT

The formal public comment period begins on Wednesday, February 15, 2012 and ends on Monday, April 2, 2012 (a total of 47 days). Interested persons are requested to submit written comments on the available documents. At the hearing, commenters are expected to summarize their written comments. Oral comments raising significant new issues not raised during the written comment period will not be permitted.

**Written comments must be submitted to the San Diego Water Board no later than Monday, April 2, 2012 at noon.**

Written comments received after this date will not be provided to the San Diego Water Board members prior to the hearing.
