## NOTICE OF APPLICATION AND PUBLIC HEARING FOR RESCISSION OF NPDES DISCHARGE PERMIT AND ISSUANCE OF WASTE DISCHARGE REQUIREMENTS

for

General Electric Hitachi Nuclear Energy Americas, LLC Vallecitos Nuclear Center 6705 Vallecitos Road, Sunol, Alameda County

The above discharger has filed an application for reissuance of a permit under the National Pollutant Discharge Elimination System (NPDES). The San Francisco Bay Regional Water Quality Control Board's (Regional Water Board's) staff has prepared a tentative order for this discharger that rescinds the existing NPDES permit and issues waste discharge requirements (WDRs) pursuant to the California Porter-Cologne Water Quality Control Act. The WDRs contain prohibitions, limitations, provisions, and monitoring requirements for the discharge.

The discharger owns and operates a nuclear research center at 6705 Vallecitos Road near Sunol. It produces about 2,900 gallons per day (gpd) of domestic sanitary wastewater and about 20,000 gpd of industrial wastewater from its operations. This wastewater is discharged to land via sprinkler irrigation. Historically, the Discharger discharged into a nearby creek, but this no longer occurs. The new WDRs no longer allow surface water discharges; they allow discharges to land only.

The Regional Water Board intends to consider adopting the tentative order during a meeting to commence at the time and location as follows:

The deadline for written comments is 5:00 p.m. on July 28, 2008. Comments must be sent to the attention of Vincent Christian. Persons wishing to file written comments on or objections to the tentative order, or other aspects of this matter must do so no later than this deadline so that such comments may be considered. No written comments will be accepted or responded to in writing if received after that deadline.

Interested persons are invited to attend and express their views at the public hearing on this matter. The Water Board will hear oral testimony, but will not accept written comments after the deadline noted above.

Pursuant to section 2050(c) of Title 23 of the California Code of Regulations, any party that challenges the Water Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Water Board at the public hearing or in timely submitted written correspondence delivered to the Water Board.
