NOTICE OF PUBLIC HEARING TO CONSIDER ADMINISTRATIVE CIVIL LIABILITY IN THE MATTER OF

**PETE'S STOP, MR. CUONG CHON HUYNH, MR. DUNG HA,
MS. KIEU HUYNH AND MR. PETER SIALARIS
PETE'S STOP, 290 KEYES STREET, SAN JOSE
SANTA CLARA COUNTY**

The San Francisco Bay Regional Water Quality Control Board (Water Board) Assistant Executive Officer has issued an administrative civil liability complaint (Complaint) proposing a liability of \$25,000 against Pete's Stop, Mr. Cuong Chon Huynh, Mr. Dung Ha, Ms. Kieu Huynh and Mr. Peter Sialaris (collectively, Dischargers) for violating Cleanup and Abatement Order No. R2-2005-0023 (CAO) by submitting late quarterly groundwater and soil vapor extraction monitoring reports. The Water Board will hold a hearing on the Complaint as follows:

Date and Time: October 8, 2008, 9:00 a.m.

Place: Elihu M. Harris State Building Auditorium, First Floor,
1515 Clay Street, Oakland, California

No hearing will be held if the Dischargers waive their right to a hearing and agree to pay the proposed civil liability as set forth in the Complaint, provided no significant public comments are received during the public comment period. At the hearing, the Water Board may affirm, reject, or modify the proposed civil liability, or refer the matter to the Attorney General for judicial enforcement.

Hearing Procedures

A copy of the procedures governing an adjudicatory hearing before the Water Board may be found at Title 23 of the California Code of Regulations, § 648 et seq.

Any persons objecting to the hearing procedures set forth herein must do so in writing by September 10, 2008, to the contact listed below.

Hearing Participation

The Water Board staff members who will be involved in this matter have been separated into two groups. One group (the "prosecution team") consists of Nathan King, John Wolfenden, Stephen Hill, Dyan Whyte and Yuri Won, an attorney with the State Water Board's Office of Chief Counsel and who advises the Board on unrelated matters. The prosecution team will

appear as parties before the Board. They have had (and will have had) no communication with Water Board members on this matter outside of the public hearing.

A separate group of staff will advise the Water Board on this matter. That group (the “advisory staff”) consists of Bruce Wolfe and Dorothy Dickey, who have had no contact with the prosecution team on this matter.

Other than prosecutorial staff, participants at the hearing are either designated as “parties” or “interested persons.” Designated parties to the hearing may present evidence and cross-examine witnesses. Designated parties are subject to cross-examination. Interested persons may make any comments to the Board, but may not offer factual evidence. Interested persons will not be subject to cross-examination, nor may they cross examine parties.

The following participants are hereby designated as parties at the hearing:

- Mr. Cuong Chon Huynh
- Mr. Dung Ha
- Ms. Kieu Huynh
- Mr. Peter Sialaris

To ensure that all participants have an opportunity to participate in the hearing, the Prosecution Team will recommend that the Chair of the Water Board establish the following time limits at the hearing:

- 20 minutes each for the prosecution team and the Dischargers to testify, present evidence, and cross examine witnesses,
- 3 minutes for interested persons to make statements to the Water Board.

Requesting Designated Party Status

Persons who wish to participate in the hearing as a designated party shall request party status by submitting a request in writing (with copies to the designated parties) no later than **5 p.m. on August 22, 2008**, to Mary Tryon, Executive Assistant, 1515 Clay Street, Suite 1400, Oakland, CA 94612. The request shall include an explanation of the basis for status as a designated party (e.g., how the issues to be addressed in the hearing and the potential actions by the Regional Water Board affect the person), the information required of designated parties as provided below, and a statement explaining why the party or parties designated above do not adequately represent the person’s interest. Any opposition to the request must be submitted by 5 p.m. on **August 25, 2008**. The parties will be notified by **5 p.m. on September 4, 2008** in writing whether the request has been granted or denied.

Written Comment and Evidence Deadline

The deadline to submit all comments and evidence to be offered at the hearing is **5 p.m. on September 10, 2008**. Persons shall submit **fourteen (14) copies** to Nathan King at 1515 Clay Street, Suite 1400, Oakland, CA 94612.
