**SUBJECT: NOTICE OF TENTATIVE ORDER TO RESCIND WASTE DISCHARGE
REQUIREMENTS FOR CENTRAL CONTRA COSTA SANITARY DISTRICT'S
BOLLINGER CANYON LEACHFIELD, CONTRA COSTA COUNTY**

Dear Mr. Potter:

The Water Board has prepared a Tentative Order to rescind Order No. 92-007, Waste Discharge Requirements for Central Contra Costa Sanitary District, Bollinger Canyon Leachfield, Contra Costa County. A copy of the Tentative Order is attached for your review and comment.

The purpose of the order is to rescind and terminate discharge requirements for this wastewater management facility. The facility was an engineered trench and pipe network system constructed by the District in 1967 for subsurface discharge of septic tank effluent. The facility served multiple properties along a one-mile stretch of Bollinger Canyon Road in unincorporated Contra Costa County. Over time the District-owned facility was superseded by independent wastewater systems owned and operated by respective individual property owners. The leachfield facility was permanently dismantled by the District in 1998. The facility no longer exists. The requirements of Order No. 92-007 are no longer relevant.

Please review the Tentative Order for accuracy of information stated and proper understanding of the requirements. You are invited to submit comments as desired. Water Board staff will review comments received, prepare comment responses and changes to the Tentative Order as appropriate, and present the matter to the Board. Board consideration is planned for the Board's meeting on March 14, 2012.

Written comments about the Tentative Order must be submitted to the Water Board by February 20, 2012.
