## NOTICE OF APPLICATION, OPPORTUNITY TO COMMENT, AND PUBLIC HEARING FOR DISCHARGE PERMIT AND RESCISSION OF CEASE AND DESIST ORDER

The above dischargers have filed an application for reissuance of a permit under the National Pollutant Discharge Elimination System. The Board's staff has prepared a tentative permit for these dischargers in accordance with the Federal Clean Water Act and the California Porter-Cologne Water Quality Control Act. Also, the tentative permit would rescind an existing cease and desist order because the dischargers would be able to comply with new limits proposed in the tentative permit.

The dischargers own and operate two wastewater treatment plants that treat a total of about 17 million gallons per day of domestic and industrial wastewater from Richmond and surrounding areas. The treated effluent from the two plants is combined and discharged through a deepwater outfall into central San Francisco Bay about 8200 feet offshore south of the Richmond San Rafael Bridge.

The deadline for receipt of comment on the tentative permit is 5:00 p.m. on March 29, 2013. Comments must be sent to the attention of Vincent Christian. Persons wishing to file written comments on or objections to the tentative permit or other aspects of this matter must do so no later than this deadline so that such comments may be considered.

The Board intends to consider adopting the tentative permit during a meeting to commence at 9:00 a.m. on **May 8, 2013**, in the Auditorium of the Elihu Harris State Building at 1515 Clay Street in Oakland. Interested persons are invited to attend and express their views at the public hearing.

Pursuant to section 2050(c) of Title 23 of the California Code of Regulations, any party that challenges the Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only those substantive issues or objections that were raised before the Board at the public hearing or in timely submitted written correspondence.
