Advisory Team,

At this time, the Prosecution Team has no objection to Mr. Hamed'i's request to waive his right to a hearing before the Board within 90 days of receiving Administrative Civil Liability Complaint No. R2-2015-1012 (Complaint). However, we would like additional information on the basis for this request; the information typically obtained through submission of

the approved "Waiver Form" issued with the Complaint and its hearing procedures. We contacted Mr. Hamed's attorney, Mr. Cheven, and asked whether he or his client plans to submit the Waiver Form or something equivalent to it. Mr. Cheven said he would send out another letter to the Advisory Team on this matter on Tuesday, September 15, 2015.
