NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Cease and Desist Order to the City of Daly City in San Mateo County.

This Tentative Cease and Desist Order is for violation of the Municipal Regional Stormwater Permit Trash Reduction Requirements.

After the Board considers adoption of the Tentative Cease and Desist Order, Water Board staff will present an information item on the 100 percent trash load reduction requirement under Provision C.10.a.i of the Municipal Regional Stormwater NPDES Permit.
