NOTICE OF OPPORTUNITY TO COMMENT ON UPDATED WASTE DISCHARGE REQUIREMENTS AND TERMINATION OF ORDER NO. R2-2004-0029 FOR THE EAST CANYON LANDFILL, BENICIA, SOLANO COUNTY

NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order (Order) for Updated Waste Discharge Requirements (WDR) Order for the closed East Canyon Landfill in Benicia. The Order would terminate existing WDR Order No. R2-2004-0029; terminate the self-monitoring program requiring groundwater, leachate, and surface water sampling; and require financial assurance for post-closure monitoring and maintenance.
