NOTICE OF OPPORTUNITY TO COMMENT AND PUBLIC HEARING ON WASTE DISCHARGE REQUIREMENTS AND TERMINATION OF ORDER NO. R2-2004-0056

AND

NOTICE OF AVAILABILITY OF PUBLIC REVIEW AND INTENT TO ADOPT AN INITIAL STUDY AND MITIGATED NEGATIVE DECLARATION FOR THE WASTE MANAGEMENT RESTORATION PROJECT

NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order for updated Waste Discharge Requirements (Tentative Order) for the Martinez Renewable Fuels Facility (Facility). The Tentative Order would terminate Order No. R2-2004-0056; update facility name and ownership information; update closure, maintenance, and monitoring requirements for waste management units (WMUs); and require a vulnerability assessment and long-term flood protection plan to address sea level rise and groundwater rise.

NOTICE IS ADDITIONALLY GIVEN THAT the Water Board intends to adopt an Initial Study and Mitigated Negative Declaration (ISMND) for closure of waste management units (WMUs) and restoration of wetlands at the Facility. The Water Board, as the Lead Agency, has prepared an ISMND pursuant to the California Environmental Quality Act (CEQA) and CEQA Guidelines for the Waste Management Unit Restoration Project (Project) that evaluates the potential environmental impacts associated with the closure and restoration of five WMUs at the Facility site.

Project Location: The Project is located at the Facility site at 150 Solano Way, approximately three miles east of the City of Martinez on the southern shore of Suisun Bay. WMUs 10, 11, and 14 are located south of the Union Pacific Railroad tracks and WMUs 31 and 32 are located to the north of the tracks within the Facility boundaries. The Facility site is subject to Regional Water Board Order 00-021, a cleanup and abatement order that includes requirements to establish trigger levels for known contaminants and to remediate subsurface petroleum contamination.

Project Description: The purpose of the Project is to close five existing WMUs and restore wetlands. The WMUs are inactive units that were created to treat and manage

refinery waste. All units formerly consisted of tidal marsh and were created by placing soil and fill to form berms and containment cells. The containment cells were then used as disposal units for solid and/or liquid wastes. Wastes deposited consisted of oily wastes, ranging from asphaltic semi-solids to liquids and sludges, and in the case of WMU 31, also locally generated dredged sediments. After the WMUs became inactive, precipitation caused ponding within the cells, the soil and waste subsided, and the WMUs became overgrown with vegetation.

Closure activities will include excavation and consolidation of waste material and associated soils, treatment of contaminated soils, fill placement, groundwater sampling, and construction of a final cover or cap in accordance with the requirements of Title 27 of the California Code of Regulations. Wetlands will be restored within WMUs 10, 11, and 31 after clean closure and WMUs 14 and 32 will be capped.

Public Review Period: October 30, 2025 - December 1, 2025
