Item 1 – Roll Call and Introductions

The meeting was called to order on March 11, 2009 at approximately 9:00 a.m. in the State Office Building Auditorium, First Floor, 1515 Clay Street, Oakland.

Board members present: John Muller, Chair; Shalom Eliahu; James McGrath; Steven Moore; William Peacock; Rameshwar Singh.

Board members absent: Terry Young, Vice-Chair.

Mr. Muller said Charles Hoppin had been appointed Chair of the State Water Resources Control Board.

Item 2 – Public Forum

Terry Preston, Mike Preston, and John Kosbsky, speaking on their own behalf, expressed concern that stormwater from a construction project is transporting sediment to an East Bay creek. Mrs. Preston gave staff an information package on the subject.

Danielle Rinsler, Planning Director, San Francisco International Airport, made comments that were directed towards Item 5C. She thanked staff for work on the Revised Tentative Order. She said Nixon Lam, Manager of Environmental Affairs, was present at the meeting.

Item 3 – Minutes of the November 12, 2008 Board Meeting

Motion: It was moved by Mr. McGrath, seconded by Mr. Moore, and it was voted unanimously to adopt the Minutes of the November 12, 2008 Board Meeting

Item 4 - Chairman's, Board Members', and Executive Officer's Reports

Mr. McGrath said he recently met with Laurel Marcus, Executive Director, California Land Stewardship Institute. He said they discussed the Fish Friendly Farming program and an offer was extended to tour some sites. Mr. McGrath said he had a telephone conversation with Jay Ach, Port of San Francisco, regarding contaminated sediments.

Mr. McGrath discussed legislative bills.

Dr. Singh said he attended a recent Water Education Workshop.

Mr. Moore reported meeting with the San Francisco Baykeeper and Baykeeper staff. He said they discussed ballast water issues.

Mr. Wolfe addressed the Board.

Dyan Whyte said staff will show two documentary films later in the day. She said the first film will focus on the work the Water Boards perform. She said the film will be used to inform the public about Water Board activities and to recruit new staff. She said the second film will focus on water, wastewater, and stormwater infrastructure systems. She said the film includes a discussion about the importance of maintaining infrastructure systems.

Item 5 – Consideration of Uncontested Items

Mr. Muller said speakers would like to be heard on Item 5A.

Mr. Wolfe recommended Item 5A be removed from the uncontested items. He said there was a supplemental to Item 5B.

Mr. Wolfe recommended adoption of Item 5B, as supplemented, and Item 5C.

Mr. Moore spoke in favor of Item 5C.

Mr. McGrath complimented staff for work on the uncontested items.

Motion: It was moved by Mr. Peacock, seconded by Mr. Eliahu, and it was voted to adopt Item 5B, as supplemented, and Item 5C, as recommended by the Executive Officer.

Item 5A – <u>Cities of San José and Santa Clara, San José/Santa Clara</u> <u>Water Pollution Control Plant and Collection System</u>, <u>San José and Santa Clara, Santa Clara County</u> – Reissuance of NPDES Permit

Tong Yin gave the staff presentation.

Dale Ihrke, Deputy Director, Environmental Services Department, City of San José, testified. He requested modifications to the Revised Tentative Order.

Mollie Dent, Senior Deputy City Attorney, City of San José, testified. She requested modifications to the Revised Tentative Order.

Alan Kurotori, Director of Water & Sewer Utilities, City of Santa Clara, testified. He requested modifications to the Revised Tentative Order.

Alexander Abbe, Assistant City Attorney, City of Santa Clara, testified. He requested modifications to the Revised Tentative Order.

Ken Greenberg, Manager, Clean Water Act Compliance Office, U.S. EPA, Region IX, testified.

Mr. Wolfe stated possible modifications to the Revised Tentative Order.

Mr. McGrath asked whether it would be helpful for the Board to consider action on the Revised Tentative Order at the next Board meeting. He asked whether staff would be able to develop a proposal for specific modifications.

Mr. Peacock concurred with Mr. McGrath.

Mr. Wolfe said at the April Board meeting, staff would recommend modifications to the Revised Tentative Order.

Mr. Muller said the Item would be continued to the April Board meeting.

Persons representing respondents introduced themselves: Jim Porter, Director of Public Works, County of San Mateo, and District Engineer, Crystal Springs County Sanitation District; Darla Reams, Deputy Director of Public Works, City of San Mateo; Martha DeBry, Public Works Director, Town of Hillsborough; Melissa Thorme, Legal Counsel on behalf of the Town of Hillsborough; John Nibbelin, Deputy County Counsel, Office of San Mateo County Counsel, and Legal Counsel on behalf of Crystal Springs County Sanitation District; and Monica Oakley, Oakley Water Strategies, on behalf of the City of San Mateo.

Introductory comments and a staff presentation were given by prosecutorial staff.

Prosecutorial staff replied to questions from Dr. Singh and a question from Mr. Muller.
