#### Item 1 – Roll Call and Introductions

The meeting was called to order on April 8, 2009 at 9:03 a.m. in the State Office Building Auditorium, First Floor, 1515 Clay Street, Oakland.

Board members present: John Muller, Chair; Terry Young, Vice-Chair; Shalom Eliahu; James McGrath; Steven Moore; William Peacock; Rameshwar Singh.

Board members absent: None.

Tam Doduc, Member, State Water Resources Control Board, and liaison to Region 2, said Frances Spivy-Weber and she had been reappointed to serve on the State Board. She said Charles Hoppin had been appointed to serve as Chair of the Board.

#### Item 2 – Public Forum

David Lewis, Executive Director, Save the Bay, said people are paying attention to the recent Board action recommending additions to the Section 303(d) list for Bay Area waters impaired by trash. He said Save the Bay is working with several other organizations to provide pollution prevention education programs to low-income students. He gave staff a copy of the current newsletter of Save the Bay.
