NOTICE OF PUBLIC HEARING NOTICE OF FILING A DRAFT ENVIRONMENTAL DOCUMENT

to amend the

Water Quality Control Plan for the San Francisco Bay Basin

NOTICE IS HEREBY GIVEN that the San Francisco Bay Regional Water Quality Control Board (Water Board) will consider an amendment to the Water Quality Control Plan for the San Francisco Bay Basin (Basin Plan) during a public hearing on April 11, 2018. Specifically, the Water Board will consider:

- 1. Establishing Site-Specific Objectives and Total Maximum Daily Load (TMDL) for Dissolved Oxygen in Suisun Marsh and an Implementation Plan;
- 2. Addressing Mercury Impairment by Including Suisun Marsh Among the Water Bodies Addressed by the San Francisco Bay Mercury TMDL.

The Board's Basin Planning Program is considered a certified regulatory program, which means that the Board is exempt from the requirement to prepare an environmental impact report for basin planning activities under the California Environmental Quality Act. (Pub. Res. Code, § 21080.5; Cal. Code Regs., tit. 14, § 15251(g).) The Board's environmental review of the proposed Basin Plan Amendment is instead contained in a draft Staff Report, which is considered to be part of the "substitute environmental documentation" or "SED". The public hearing to adopt the proposed amendment and draft SED will be held as follows:

SUBMISSION OF WRITTEN COMMENTS: The 45-day public comment period for the proposed amendment and SED begins on January 12, 2018. Comment letters must be received by 5:00 p.m. on Wednesday February 28, 2018. Please send all written comments to the staff contact identified above. Additionally, all evidence, testimony, and exhibits to be offered at the hearing must be submitted in writing by this date to the above staff contact. Non-evidentiary policy statements to be made at the hearing need not be submitted in advance.

Prior to the hearing, Water Board staff will post on the above website any proposed changes to the proposed Basin Plan amendment and/or accompanying staff report, along with written responses to all comments received during the public comment period. Any changes in the date of the hearing, the availability of responses to comments or any other updates will be noticed on the above website.

The Water Board will receive oral public testimony on the proposed amendment at the hearing. At the conclusion of the hearing, the Water Board will consider adoption of the proposed Basin Plan amendment, including changes to the proposed amendment that are consistent with the general purpose of the proposed amendment and are a logical outgrowth of the evidence and testimony received. Alternatively, in response to written comments and testimony received, the Water Board may recommend that staff make changes to the proposed amendment to be presented for its consideration at a subsequent hearing.

The public hearing will be conducted in accordance with the California Code of Regulations, title 23, section 649.3. Time limits may be imposed on oral testimony at the public hearing; groups are encouraged to designate a spokesperson. All exhibits presented at the hearing, including charts, graphs, and other testimony must be left with the Water Board. They will become part of the administrative record.
