**NOTICE OF ADOPTION OF SETTLEMENT AGREEMENT AND ENTRY OF ORDER
R8-2022-0028 FOR AFG DEVELOPMENT LLC, WDID NO. 8 33C392836**

Dear Mr. Guthrie:

Order R8-2022-0028 was signed by the Santa Ana Regional Water Quality Control Board (Regional Water Board), or its delegee, on May 17, 2022, adopting the proposed settlement signed by AFG Development, LLC.

The Order requires AFG Development LLC to pay \$1,968 in mandatory minimum penalties to the Regional Water Board under Water Code section 13399.33. Payment is due **June 17, 2022**, and shall be in the form of a check made payable to the Waste Discharge Permit Fund and shall have the number of this Order (R8-2022-0028) written upon it.
