### **NOTICE OF ADOPTION OF SETTLEMENT AGREEMENT AND ENTRY OF ORDER R8-2021-0072 FOR CD ZODIAC W DID NO. 8 361020206**

Dear Mr. Lovers:

Order R8-2021-0072 was signed by the Santa Ana Regional Water Quality Control Board (Regional Water Board), or its delegee, on April 6, 2022, adopting the proposed settlement signed by CD Zodiac. The Order required CD Zodiac to pay \$1,907 in mandatory minimum penalties to the Regional Water Board under Water Code section 13399.33. Payment was fulfilled on February 24, 2022.

Please review the Order carefully to ensure that you understand all aspects of its requirements. In addition, please submit a Notice of Termination for the site since you have moved from that location.
