## NOTICE OF ADOPTION OF SETTLEMENT AGREEMENT AND ENTRY OF ORDER R8-2022-0026 OR HIGHLAND HOSPITALITY LLC, 16757 SLOVER AVENUE, FONTANA, WDID NO. 8 36C392193

Dear Mr. Cardenas and Mr. Trone:

Order R8-2022-0026 was signed by the Santa Ana Regional Water Quality Control Board (Regional Water Board), or its delegee, on June 2, 2022, adopting the proposed settlement that was signed by Highland Hospitality LLC on April 6, 2022.

The Order requires Highland Hospitality LLC to pay \$1,850 in mandatory minimum penalties to the Regional Water Board under Water Code section 13399.33. Payment is due **July 2, 2022** and shall be in the form of a check made payable to the Waste Discharge Permit Fund and shall have the number of this Order (R8-2022-0026) written upon it.
