Regional Board records indicate that Highland Hospitality LLC is operating a construction site identified as 16757 Slover Avenue, located at 16757 Slover Avenue, in the City of Fontana. This site is identified in our records by WDID: 8 36C392193. Section XVI.A of the Construction General Permit requires that an Annual Report be submitted by September 1st of each year via the online SMARTS database.

Over 90% of regulated facilities comply with this requirement. Our records show that your annual report for the July 1, 2020 to June 30, 2021 reporting period is one of the few that have not been submitted. We request that you submit a complete 2020-2021 Annual Report via the online SMARTS database no later than **December 27, 2021**.

Regional Board records indicate that Highland Hospitality LLC is operating a construction site identified as 16757 Slover Avenue, located at 16757 Slover Avenue in the City of Fontana. This site is regulated under the Construction General Permit and is identified by WDID 8 36C392193-Application ID:529094. Section XVI.A. of the General Permit requires that an Annual Report be submitted by September 1st each year via the online SMARTS database.

The first Notice of Non-compliance (NNC) was sent to you on November 23, 2021. In the November 23, 2021 NNC, we requested that you submit the 2020-21 Annual Report via the online SMARTS database no later than December 27, 2021.

Our records show that Highland Hospitality LLC's annual report for the July 1, 2020 to June 30, 2021 reporting period was not submitted by September 1, 2021. Highland Hospitality LLC is consequently in violation of Section XVI.A. of the General Permit for failure to submit a complete 2020-2021 Annual Report. Highland Hospitality LLC has also not submitted the late annual report by December 27, 2021 as requested in the November 23, 2021 NNC.
