New Provisions:

In addition to the permittee substitutions specified in Table 1, Order R8-2021-0008 shall be amended to incorporate the following provisions at the end of the "Provisions" section:

- 1. The Discharger shall maintain a copy of Order R8-2025-0071 at the Project site.
- 2. The Discharger shall remain authorized to discharge waste to the waters of the State (WOTS) for five years following the adoption of Revision Order R8-2025-0071 (any reporting requirements shall continue to remain in effect). Thereafter, the Discharger shall file a new dredge and fill application in accordance with California Code of Regulations, title 23, division 3, chapter 9 no later than 180 days in advance of this expiration date. The application, with filing fee, will be discussed between the Discharger and Santa Ana Water Board staff regarding any need for additional information and changes in fees prior to the issuance of new WDRs.
