**NOTICE OF PUBLIC HEARING
FOR
WASTE DISCHARGE REQUIREMENTS FOR DREDGED OR FILL DISCHARGES TO
WATERS OF THE STATE
TENTATIVE ORDER NO. R8-2022-0029**

NOTICE IS HEARBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order No. R8-2022-0029 (Tentative Order) to Diversified Pacific Communities (Discharger) for Tentative Tract Map No. 37731 (Project). The Project is to construct a residential development on a 35.8-acre property, consisting of 138 single-family dwellings, private streets, and common open space, as well as four (4) detention or water treatment basins.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing a regularly scheduled Santa Ana Water Board meeting as follows:
