NOTICE OF PUBLIC HEARING FOR TENTATIVE ORDER NO. R8-2023-0009

WASTE DISCHARGE REQUIREMENTS AND MASTER RECYCLING PERMIT FOR EAST VALLEY WATER DISTRICT STERLING NATURAL RESOURCE CENTER

NOTICE IS HEREBY GIVEN THAT the California Regional Water Quality Control Board, Santa Ana Region (Santa Ana Water Board) is releasing for public review and comment tentative Order No. R8-2023-0009 (Tentative Order), which will serve as Waste Discharge Requirements (WDRs) and Master Recycling Permit for the East Valley Water District's (EVWD's) Sterling Natural Resource Center (SNRC). Using a mailing address of 31111 Greenspot Road, Highland, CA 92346, EVWD applied for issuance of WDRs and Master Recycling Permit, Tentative Order No. R8-2023-0009, under Sections 13263 and 13523.1 of the California Water Code for the SNRC located at 25376 5th Street, San Bernardino, CA 92410. In addition, the Tentative Order includes the approval of a new pretreatment program and pretreatment program requirements for the implementation of an effective pretreatment program pursuant to California Code of Regulations, title 23, section 2233 and 40 Code of Federal Regulations (CFR) Part 403.

EVWD owns and will operate the SNRC, a new facility, that is in the southwestern area of San Bernardino County and will produce tertiary treated and disinfected recycled water for indirect potable and non-potable reuse. The Tentative Order authorizes the production of tertiary treated and disinfected recycled water to up to 8 million gallons per day and the surface application of the recycled water into the Bunker Hill-B Groundwater Management Zone (indirect potable reuse) and the distribution of recycled water for non-potable reuse.

The Santa Ana Water Board will hold a public hearing to consider adoption of the Tentative Order as follows:
