WASTE DISCHARGE REQUIREMENTS FOR
IN-SITU REMEDIATION OF SOIL AND GROUNDWATER
AT THE FORMER WEISER LOCK FACILITY
HUNTINGTON BEACH, ORANGE COUNTY**

TENTATIVE ORDER R8-2023-0008

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2023-0008 (Tentative Order), which will serve as Waste Discharge Requirements for the discharge of chemical amendments into the subsurface at the Former Weiser Lock Facility (5555 McFadden Avenue, Huntington Beach) to promote soil and groundwater remediation of volatile organic compounds (VOCs) and 1,4-dioxane within the specified treatment zone (in-situ). With proper management and monitoring as required by the Tentative Order and associated Monitoring and Reporting Program, any potential adverse effects will be localized, of short duration, and are not expected to unreasonably impair any existing or prospective beneficial uses of groundwater.
