NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2023-0040 (Tentative Order), which will amend existing Waste Discharge Requirements for the discharge of chemical amendments into the subsurface at the Former Lockheed Martin Beaumont Site 2, Laborde Canyon (96501 Jack Rabbit Trail, Beaumont) to promote in-situ groundwater remediation of perchlorate within the biobarrier zone. The amendment would allow additional emulsified vegetable oil (EVO) replenishment of the biobarrier to maintain optimal conditions for perchlorate biodegradation.
