TENTATIVE ORDER R8-2025-0078

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2025-0078 (Tentative Order), which will serve as Waste Discharge Requirements for the discharge of amendments into the subsurface at the Walgreens Store No. 11652 Facility (1726 Superior Avenue, Costa Mesa). The objective of the Waste Discharge Requirements is to promote in-situ remediation of groundwater impacted by volatile organic compounds (VOCs) within the specified treatment zone. With proper management and monitoring as required by the Tentative Order and associated Monitoring and Reporting Program, the discharge will be consistent with the maximum benefit to the people of the state, and will not unreasonably impair any existing or prospective beneficial uses of groundwater. Such comments will generally be limited to three minutes, though the Board Chair may grant additional time on a case-by-case basis.
