#### NOTICE OF PUBLIC HEARING AND ADDITIONAL WRITTEN COMMENT PERIOD ON THE AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SANTA ANA RIVER BASIN TO INCORPORATE REVISED TOTAL MAXIMUM DAILY LOADS FOR NUTRIENTS IN LAKE ELSINORE AND CANYON LAKE, RIVERSIDE COUNTY, CALIFORNIA

**NOTICE IS HEREBY GIVEN THAT** the California Regional Water Quality Control Board, Santa Ana Region ("Santa Ana Water Board") will hold a public hearing consider a resolution to approve the draft amendment to the Water Quality Control Plan for the Santa Ana River Basin (Basin Plan) to incorporate Revised Total Maximum Daily Loads (TMDLs) for Nutrients in Lake Elsinore and Canyon Lake ("Basin Plan amendment"). The Santa Ana Water Board will also accept written comments on changes to the draft TMDL documents that staff circulated in December.

#### PUBLIC HEARING

The Santa Ana Water Board will hold a public hearing to consider adoption of the draft Basin Plan amendment. The public hearing will be held at the following date, time, and location:

The hearing will be recorded. A copy of the recording will become part of the administrative record. The hearing will occur in a physical meeting location with an option for the public to participate from a remote location. ## WRITTEN PUBLIC COMMENTS

The Santa Ana Water Board accepted written comments on the TMDL from December 27, 2024, through February 10, 2025. Staff has revised the proposed Basin Plan amendment and supporting documentation in response to comments from the City of Banning. The revisions remove the City of Banning as a party responsible for the MS4 Jurisdiction Runoff wasteload allocation (WLA) and make minor changes to the TMDL's interim milestones (numeric targets) and WLAs consistent with that change.

The revisions are available in redline/strikeout format on the Lake Elsinore and Canyon Lake TMDL webpage. The Santa Ana Water Board will accept written public comments regarding these revisions. Comments unrelated to the revisions will not be accepted. People interested in the revisions to the Basin Plan amendment and supporting documents are encouraged to submit comments electronically. Comment letters must be received **by 12:00 P.M. on June 30, 2025**. Comment letters received after that deadline will not be accepted unless the Santa Ana Water Board determines otherwise.
