NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2024-0056 (Tentative Order) for the Verdemont TTM 16794 (Project). The Project encompasses the construction of 44 single-family residential and associated infrastructure on 18.45 acres within the City of San Bernardino. The construction of the Project would result in the permanent physical loss of 0.05-acre of ephemeral waters of the State. The permanent impacts are a result of mass grading for site preparation.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
