#### **TENTATIVE ORDER R8-2025-0063**

**NOTICE IS HEREBY GIVEN** that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Order R8-2025-0063) (Tentative Order) for the Oak Hills West Residential Tract 38652 (Project).

The Project encompasses the development of a single-family residential subdivision, to provide additional residential housing units and associated infrastructure in the City of Menifee. The Project consists of 37 residential lots plus a common area on an approximately 15.5-acre, located on the eastern portion of the 77.81-acre property. The remainder of the property will remain undisturbed open space. The Project will result in the permanent physical loss of 0.39 acres of ephemeral streambed. The permanent impacts are a result of mass grading for the construction of a roadway manufactured slopes, residential development, fuel modification zones, retaining wall, v-ditch, splash wall, placement of riprap, and storm drains.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:
