NOTICE OF PUBLIC HEARING

REVISION ORDER R8-2025-0064

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is releasing for public review and comment tentative Revision Order R8-2025-0064 (Tentative Order), which will revise Order R8-2021-0016, and accompanying amended Order R8-2022-0007 (Affected Order) to substitute the discharger for regulatory coverage.

The Affected Order prescribes Waste Discharge Requirements (WDRs) for the Sycamore Heights Residential Development Project. Apart from transferring permit coverage, no other changes to the Affected Order are proposed at this time.

The Santa Ana Water Board intends to consider adopting the Tentative Order during a public hearing at a regularly scheduled Santa Ana Water Board meeting as follows:

Such comments will generally be limited to three minutes, though the Board Chair may grant additional time on a case-by-case basis.
