NOTICE OF SCOPING MEETING

TRIENNIAL REVIEW OF THE WATER QUALITY CONTROL PLAN FOR THE SANTA ANA RIVER BASIN FISCAL YEARS 2024-2027

NOTICE IS HEREBY GIVEN that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is commencing the triennial review of the Water Quality Control Plan for the Santa Ana River Basin (Basin Plan). The Basin Plan prescribes the water quality objectives/standards for ground and surface waters in the region covering the Santa Ana River Watershed in Orange, Riverside, and San Bernardino counties. Section 13240 of the Porter-Cologne Water Quality Control Act and section 303(c)(1) of the federal Clean Water Act requires review of basin plans at least once every threeyear period to incorporate key changes in regulations, policies, and physical changes within the region. The Santa Ana Water Board is responsible for reviewing the Basin Plan and is required to: 1) identify those portions of the Basin Plan, which need modification or new additions; 2) adopt water quality objectives/standards as appropriate; and 3) recognize those portions of the Basin Plan, which are appropriate as written. The Santa Ana Water Board solicits written and oral input, which it will consider prior to adopting the prioritized list of basin planning projects. The highest priority projects will establish the workplan for the next three-year period.

Santa Ana Water Board staff will hold a scoping meeting to provide information on our prioritized list of basin planning projects and receive public input for the subject triennial review.
