STATE WATER RESOURCES CONTROL BOARD PLAN TO PREPARE A RESOLUTION REGARDING CULTURAL AND SUBSISTENCE FISHING BENEFICIAL USES

The State Water Resources Control Board recognizes the importance of identifying tribal and cultural uses within water quality control plan beneficial use designations and is currently seeking input regarding appropriate language for creating tribal and cultural beneficial use designations. Currently, only the North Coast Regional Water Quality Control Board (Region 1) explicitly recognizes traditional and tribal cultural uses of water by indigenous (native) peoples as beneficial uses in its basin plan with the following designations:

Commercial and Sport Fishing (COMM) is defined as "uses of water for commercial or recreational (sport) collection of fish, shellfish, or other aquatic organisms including, but not limited to, uses involving organisms intended for human consumption, including human subsistence and/or for bait purposes."

Native American Culture (CUL) is defined as "Uses of water that support the cultural and/or traditional rights of indigenous people such as subsistence fishing, basket weaving and jewelry material collection, navigation to traditional ceremonial locations, and ceremonial uses."

While the State Water Board explores the appropriate means to address tribal and cultural beneficial use designations in the long term through including language in upcoming State wide plans and policies, the State Water Board is proposing a first step measure through issuing a resolution to set the foundation for future State Water Board actions to recognize traditional and tribal cultural uses of water by indigenous peoples. This resolution is expected to direct Regional Water Boards to consider developing beneficial use designations consistent with language presented in the resolution.

While this resolution will not specifically create a designation, it will present existing North Coast Regional Board language, and the State Water Board welcomes your input on the above language. We encourage CA tribes to discuss this beneficial use language in preparation for engaging in conversations on the proposed resolution in the coming months. We understand that dialogues among tribes and tribal organizations have already begun and we are encouraged by these intertribal efforts.
