## UPDATED EXAMS FOR CALIFORNIA UNDERGROUND STORAGE TANK INTERNATIONAL CODE COUNCIL CERTIFICATION

To: Local Agencies, Service Technicians, Designated Operators, and Other Interested Persons

The purpose of this letter is to advise that as of July 1, 2012 exam content has been updated for certifications issued by the International Code Council (ICC) for the California Underground Storage Tank (UST) System Operator (UC), California UST Inspector (UI), and California UST Service Technician (UT). Correspondingly, the *ICC CA UST Exam Reference Book* has also been updated. Revisions to the exams and exam reference materials are representative of recent changes to UST regulations and the publication of best management practices that occurred on or after March 2007.

For a complete review of revised *ICC CA UST Exam Reference Book* contents and related materials please see enclosure *California UST Certification Exam References*. The most significant changes to the exam reference materials are that *Straight Talk on Tanks* will no longer be used, and two new references were added. The Petroleum Equipment Institute (PEI) Recommended Practices (RP) 500<sup>1</sup> and PEI RP900<sup>2</sup> are now included as references for all three exams.

The exams remain open book for the UC and UI, and the *ICC CA UST Exam Reference Book* will be provided at the testing center for use during the exam. However, those taking the UC and UI exams starting July 1, 2012 will need to bring the *PEI RP500* and *PEI RP900* references with them to the exam center, as they are not included in the *ICC CA UST Exam Reference Book*. PEI publications can be purchased at <a href="https://www.pei.org">www.pei.org</a>. The exam remains closed book for the UT.
