BACKGROUND

Draft Cease and Desist Orders

On December 28, 2009, the State Water Resources Control Board ("State Water Board" or "Board"), Division of Water Rights ("Division"), issued a Draft Cease and Desist Order ("CDO") to Eddie Vierra Farms ("Vierra"). On January 8, 2010, Vierra requested a hearing on this Draft CDO.

On January 13, 2010, the Division issued a Draft CDO to Loren and Dolores Ohm ("Ohm"). On February 2, 2010, Ohm requested a hearing on this Draft CDO.

On January 4, 2010, the Division issued a Draft CDO to the George Speckman Testamentary Trust ("Speckman"). On February 1, 2010, Speckman requested a hearing on this Draft CDO. On April 7, 2010, the State Water Board issued a notice of public hearing on this Draft CDO. After re-scheduling this hearing, the State Water Board issued a notice of postponement of this hearing on June 17, 2010.

E. JOAQUIN ESQUIVEL, CHAIR | EILEEN SOBECK, EXECUTIVE DIRECTOR

All three of these Draft CDOs allege that the parties listed in the Draft CDOs made unauthorized diversions of water from various waterbodies in the southern portion of the Sacramento-San Joaquin Delta. (Vierra, Ohm and Speckman are collectively referred to in this notice as the "Respondents.") The State Water Board has not conducted any proceedings regarding any of these three draft CDOs.

Administrative Hearings Office

In 2018, the Legislature and the Governor approved Assembly Bill No. 747, which added sections 1110-1114 to the Water Code, effective July 1, 2019. (2018 Cal. Stats., ch. 668.) Water Code section 1110 established the Administrative Hearings Office ("AHO") within the State Water Board. Water Code section 1112, subdivision (a)(2), provides that AHO hearing officers shall preside over hearings involving notices of proposed cease and desist orders under Water Code section 1834.

On January 3, 2020, Erik Ekdahl, Deputy Director of the State Water Board's Division of Water Rights, sent a memorandum to Eileen Sobeck, the State Water Board's Executive Director, proposing to transfer the proceedings regarding the three Draft CDOs described above to the AHO. On February 7, 2020, Ms. Sobeck issued a memorandum assigning these proceedings to the AHO.

PURPOSE OF STATUS CONFERENCE

Considering this background and the substantial amounts of time that have elapsed since the Division issued the Draft CDOs and the Respondents requested hearings, the AHO has decided to hold a status conference during which the Parties may address the following issues:

- (1) Do the Division and the State Water Board's Office of Enforcement ("Office of Enforcement") still want final CDOs to be issued in these proceedings?
- (2) If so, do the Division and the Office of Enforcement want to amend the prior Draft CDOs before the AHO holds hearings in these proceedings?
- (3) Do the Respondents still want the State Water Board to hold hearings on the Draft CDOs?
- (4) If the Division and the Office of Enforcement want to proceed and the Respondents want the State Water Board to hold hearings, then what are the appropriate processes and schedules for pre-hearing submittals of exhibits and testimony?
- (5) Should the AHO consider the status of the actions by the Court of Appeal for the Third Appellate District in *Modesto Irrigation District v. Tanaka*, No. C083430, or the State Water Board's actions in the pending *Mussi, Pak and Young* matters (see

https://www.waterboards.ca.gov/waterrights/water_issues/programs/hearings/mu ssietal_cdo/ and

https://www.waterboards.ca.gov/waterrights/water_issues/programs/hearings/pak_ young/) when the AHO sets the schedules for pre-hearing submittals of exhibits and testimony, and the hearing schedules, in the Vierra, Ohm and Speckman proceeding or proceedings? (The AHO is not involved in the *Mussi, Pak and Young* matters.)

- (6) Should the AHO hold one, unified hearing on all three Draft CDOs, or three separate hearings, one on each Draft CDO?
- (7) If the AHO decides to hold hearings in these matters, then when should the hearings be held?
- (8) Which State Water Board staff will be members of the Prosecution Team (described below)?
- (9) What is the appropriate service list or lists for these proceedings?

HEARING OFFICER AND HEARING TEAM

A hearing officer from the State Water Board's Administrative Hearings Office will preside at the status conference and during any subsequent hearings. Other members of the AHO may be present and assist the hearing officer during the status conference, the hearing or hearings, and throughout these proceedings.

PROSECUTION TEAM

If the Division and the Office of Enforcement decide to proceed with the Draft CDOs in these proceedings, then the State Water Board Prosecution Team will be comprised of attorneys from the State Water Board's Office of Enforcement, and possibly the State Water Board's Office of Chief Counsel, and staff from the State Water Board's Division of Water Rights. During the status conference, the AHO hearing officer will ask the Prosecution Team to specify its members.

SEPARATION OF FUNCTIONS; PROHIBITION ON EX PARTE COMMUNICATIONS

All Parties, including the Prosecution Team, are prohibited from having any *ex parte* communications with any members of the AHO hearing team. (See Wat. Code, § 1110, subd. (c); Gov. Code, §§ 11430.10-11430.80.) For a discussion of *ex parte* communications regarding State Water Board members, see "Ex Parte Questions and Answers," available on the State Water Board's website at: <u>http://www.waterboards.ca.gov/laws_regulations/docs/exparte.pdf</u>. These rules regarding *ex parte* communications apply to all members of the AHO hearing team. If any Party wants to communicate with the AHO at any time regarding any procedural or substantive issue regarding these proceedings, including any issue regarding the status conference, hearing procedures or filing of documents, then that Party shall make such communication to the AHO in writing (by e-mail or letter) and serve all other Parties with copies of the communication and include a proof of service demonstrating such service with the written communication to the AHO. A Party may provide this proof of service through a formal proof of service or by other verification. For e-mails, the verification shall be a list of the e-mail addresses of the Parties or their representatives in an electronic-mail "cc" (carbon copy) list. For letters, the verification shall be a list of the names and mailing addresses of the other Parties or their representatives in the cc portion of the letter.

Before the AHO circulates the list of Parties described below, any Party submitting any document to the AHO for this proceeding (including the Party's NOI, described below) shall transmit copies of the document to all of the other Parties listed in the attached proof of service. After the AHO circulates the list of Parties that have filed NOIs, any Party submitting any document to the AHO shall transmit copies of the document to all of the other Parties any document to all of the other Parties any document to all of the other Party files any document to all of the other Parties and that confirms that the Party has transmitted copies of the document to all other Parties and that describes the method of service.

Please do not attempt to communicate by telephone or in person with any AHO hearing team member regarding these proceedings, because other Parties would not be able to participate in such communications. If oral communications with any members of the AHO hearing team are necessary to discuss any procedural or substantive issue, then the AHO will set up a conference call in which representatives of all Parties may participate. Any Party may request such a conference call at any time using the written communications protocols described above.

NOTICES OF INTENT TO APPEAR

Any Person or Entity that wants to participate in this Status Conference must file a Notice of Intent to Appear ("NOI"), using the form in this notice, with the AHO before the deadline listed below. The AHO encourages Parties to agree to accept electronic service (by e-mail) of all documents regarding this hearing. If a Party is not willing to do this, then the Party may check the appropriate box on the NOI form. If this box is not checked, then the AHO will assume that the Party agrees to accept electronic service.

If the AHO does not receive an NOI from the Prosecution Team indicating the Prosecution Team's intent to participate in the status conference before the deadline specified below, then the AHO may dismiss the Draft CDOs without further notice or opportunity for hearing. The Prosecution Team must file an NOI to preserve the Prosecution Team's rights to seek ACLs in these matters. If the AHO does not receive an NOI from any of the Respondents indicating the Respondent's intent to participate in the status conference before the deadline specified below, then the AHO may deem the Respondent's prior request for a hearing regarding the Draft CDO to be withdrawn and the AHO may issue a Final CDO without further notice or opportunity for hearing. Each Respondent must file an NOI to preserve Respondent's right to a hearing.

Within one week after the deadline to submit NOIs, the AHO will circulate a list of the Parties that have filed NOIs to all Parties and post that list on the AHO's webpage.

STATUS CONFERENCE STATEMENTS

On or before the deadline listed below, each Party shall submit and serve a status conference statement that separately addresses each of the status conference issues listed above that the Party wants to address. The Parties also may include in their status conference statements discussions of any other issues they believe are relevant.

SETTLEMENT

In this proceeding, the Prosecution Team is prosecuting the Respondents for alleged violations of the Water Code. The Prosecution Team and any of the Respondents may engage in private settlement discussions and may, or may not, include other persons in those discussions. Because of the separation of functions discussed above, no member of the AHO hearing team will participate in such settlement discussions or receive any evidence of what occurred during them (except for a written settlement agreement, if the Parties negotiate and sign such an agreement and submit it to the AHO). If the Prosecution Team and any of the Respondents enter into a written settlement signed by representatives of both Parties, then they should notify the AHO of this agreement, using the procedures for submitting documents described above, as soon as possible.
