SUPPLEMENTAL NOTICE OF HEARING AND NOTICE OF CONVERSION OF IN-PERSON HEARING TO TELECONFERENCE HEARING

The State Water Resources Control Board
Administrative Hearings Office
will hold a Public Hearing on the pending petitions of

the County of Sacramento and the Sacramento County Water Agency

to change water-right Licenses 1062 and 4060 (Applications A001061 and A014494), which authorize diversions of water from the Sacramento River in Sacramento County, and related issues regarding whether these licenses should be revoked.

The Public Hearing will be held on August 13, 2020 from 9:00 am to 5:00 pm

and will be held by Zoom teleconference.

Due to the ongoing COVID-19 pandemic and the associated closure of the Cal EPA Building to the public, the Administrative Hearings Office ("AHO") has changed the inperson hearing that was scheduled for August 3, 13 and 31, 2020 in this matter to a Zoom teleconference hearing that will be held only on August 13, beginning at 9:00 am.

The Zoom teleconference hearing will be recorded electronically and the AHO will post audio-only and audio-plus-video files of the hearing on the AHO-FTP site after the hearing. To facilitate a clear understanding of who is speaking, the hearing officer will ask each person to identify himself or herself as necessary during the hearing. The AHO will not order a court reporter for this hearing. Any interested party may order a court reporter at his, her or its own expense.
