## NOTICE OF CANCELLATION OF HEARING

## TO ALL PARTIES:

The State Water Resources Control Board ("State Water Board"), Administrative Hearings Office ("AHO"), issued a Notice of Public Hearing in this matter on August 27, 2020. This notice scheduled hearings on the amended Draft Cease and Desist Order ("CDO") that the Delta Watermaster issued on June 12, 2020 to Eddie Vierra Farms, LCC ("Respondent"). This notice scheduled three separate hearings on issues associated with the following three properties of Respondent: (1) Home Ranch; (2) Woods Ranch; and (3) Walker Ranch.

On October 19, 2020, the AHO received a copy of a settlement agreement, signed by the Delta Watermaster and a representative of Respondent, concerning the issues raised by the Home Ranch portion of the June 12, 2020 Draft CDO. On October 21, 2020, the AHO issued a notice of cancellation of the hearing on the Home Ranch issues that was scheduled for November 19 and 20, 2020.

On October 23, 2020, the AHO received a copy of a settlement agreement, signed by the Delta Watermaster and a representative of Respondent, concerning the issues raised by the Woods Ranch portion of the June 12, 2020 Draft CDO. On October 28, 2020, the AHO issued a notice of cancellation of the hearing on the Woods Ranch issues that was scheduled for December 2 and 3, 2020.

On October 30, 2020, the AHO received a copy of a settlement agreement, signed by the Delta Watermaster and a representative of Respondent, concerning the issues raised by the Walker Ranch portion of the June 12, 2020 Draft CDO. The AHO also received a proposed order that would approve this settlement agreement. Now that the AHO has received these documents, the AHO cancels the hearing on the Walker Ranch issues that was scheduled for January 7 and 8, 2021.

The AHO will review the proposed settlement orders and prepare a settlement order approving these settlement agreements and transmit that proposed order to the Board's Executive Director for her consideration.
