REVISED NOTICE OF EXTENSION OF DEADLINE FOR TRANSMITTAL OF PROPOSED ORDER

The State Water Resources Control Board Administrative Hearings Office held a hearing regarding the pending petitions of

Trimont Land Company and Northstar Community Services District

for water-right Permits 15905, 15906, 16618 and 16619 (Applications 22822, 22823, 23851 and 23849), which authorize diversions of water from Unnamed Streams, Unnamed Springs, Sawmill Flat Springs, Martis Creek, and West Martis Creek in Placer County.

On March 24, 2021, the Administrative Hearings Office (AHO) of the State Water Resources Control Board (State Water Board or Board) issued a Notice of Pre-Hearing Conference and Public Hearing in this matter. The applicable statutes, hearing issues and pre-hearing and hearing schedules are described in the March 24 notice.

On May 5, 2021, the AHO held the pre-hearing conference described in the March 24 notice. On May 24, 2021, the AHO issued a Pre-Hearing Conference Order, which, among other things, re-scheduled the hearing to August 6, 2021.

The AHO held the hearing on August 6, 2021, and then issued a Post-Hearing Order and Notice of Supplemental Hearing on August 9, 2021. Among other things, this order and notice scheduled a supplemental hearing for October 27, 2021. The AHO held the supplemental hearing on October 27, 2021.

On October 28, 2021, the AHO issued a Post-Hearing Order and Notice of Supplemental Hearing, which, among other things, scheduled a second supplemental hearing for December 3, 2021. The AHO held the second supplemental hearing on December 3, 2021. This matter was deemed submitted on December 3, 2021.

Under Water Code section 1114, subdivision (c)(1), the AHO is to prepare a proposed order in this matter within 90 days of this submittal date, that is, by March 2, 2022, unless the AHO extends this deadline.

As authorized by Water Code section 1114, subdivision (c)(1), the AHO extends this deadline by 30 days to April 1, 2022. This extension is necessary because of the delays in completing the proposed order the AHO has experienced due to the need to

work on other matters. The AHO intends to complete a draft proposed order and to transmit it to everyone on the service list, and to vacate the December 3, 2021 submission of this matter, on or before this new deadline.

This notice supersedes the February 28, 2022 Notice of Extension of Deadline for Transmittal of Proposed Order in this matter.
