Dear Parties:

Based on our discussion during the pre-hearing conference last week, I have decided to revise the hearing schedule in this proceeding. These revisions will allow the applicant to offer the incidental take permit (ITP) for the project, which the applicant expects will be issued by the Department of Fish and Wildlife in October, into the evidentiary record during the rebuttal phase of the hearing. I believe this schedule will result in a more efficient proceeding than offering the ITP in a surrebuttal or second phase of the hearing. In addition, this schedule accommodates the protestants' requests for additional time to prepare case-in-chief exhibits.

I have attached a draft of the revised schedule, which is subject to some amendment as I incorporate the schedule into an amended hearing notice. The deadline for submission of case-in-chief exhibits will not, however, be before July 1. I intend to incorporate this schedule into an amended hearing notice which the AHO will circulate within the next few weeks.
