# NOTICE OF PUBLIC HEARING AND SUBSEQUENT BOARD MEETING

TO CONSIDER ADOPTION OF PROPOSED AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR ENCLOSED BAYS AND ESTUARIES OF CALIFORNIA, PART 1, SEDIMENT QUALITY OBJECTIVES

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will hold both a Public Hearing to seek comments on, and a Board Meeting to consider adoption of, proposed amendments to the Water Quality Control Plan (Plan) for Enclosed Bays and Estuaries of California, Part 1, Sediment Quality Objectives.

### **BACKGROUND**

In 2003, the State Water Board initiated a program to develop sediment quality objectives (SQOs) for toxic pollutants in enclosed bays and estuaries. On September 16, 2008, the State Water Board conducted a public hearing and adopted the Plan. The Plan became effective on August 25, 2009. The SQO protecting benthic communities relies on multiple lines of evidence, which integrate chemistry, toxicity, and the condition of the benthic community to assess sediment quality for aquatic life protection. The SQO protecting human consumers of fish and shellfish relies on human health risk assessment protocols to assess sediment quality relative to bioaccumulation of contaminants from sediment into seafood.

As part of its ongoing efforts to develop better sediment quality assessment tools to support the SQOs, State Water Board staff conducted a California Environmental Quality Act (CEQA) scoping meeting on May 19, 2010 to inform the Public on recent development efforts and plans for developing draft amendments to the plan. Based upon comments received, staff redirected

their efforts to focus on protecting resident finfish and wildlife. These receptors and administrative changes are described in the environmental document and staff report supporting the proposed amendments that are the subject of the Public Hearing on April 4, 2011 and the subsequent Board Meeting on April 6, 2011.

The proposed amendments include narrative SQOs protecting wildlife and resident finfish and a framework for implementing the narrative SQOs for wildlife and resident finfish. The proposed amendments also include non-substantive and other minor changes to the existing Plan.
