COMMENTS ON THE DRAFT INITIAL STUDY/MITIGATED NEGATIVE DECLARATION STATEWIDE GENERAL WASTE DISCHARGE REQUIREMENTS FOR THE DISCHARGE OF WASTES AT COMPOST MANAGEMENT UNITS

The Los Angeles County Department of Public Works appreciates the opportunity to provide the following comments on the State Water Resources Control Board's (SWRCB) Draft Initial Study/Mitigated Negative Declaration, Statewide General Waste Discharge Requirements for the Discharge of Wastes at Compost Management Units:

- **6.4. BIOLOGICAL RESOURCES.** Paragraph d) should be marked as "less than significant impact" as there may be some impacts on the movement of any native resident and migratory fish or wildlife species or with established native resident or migratory corridor or impede the use of native wildlife nursery sites during the construction and operation of a CMU.
- **6.14. PUBLIC SERVICES.** Paragraph a) should be marked as "less than significant impact" as there may be some impacts on public fire protection service in term of maintaining acceptable fire service rations, response times, etc. do to the potential dangers associated with fire resulted from the spontaneous combustion of working piles in the CMU.
- **6.18. MANDATORY FINDINGS OF SIGNIFICANCE.** This section should address the implementation of the monitoring program and probable issues associated with it such as ponding water. There should be
