I understand that you are seeking scoping feedback on scope for wetland and riparian area policy.

Please consider to include in your scoping adjacent ecosystems, such as coastal bluffs and mesas.

With only 10% of wetlands left in California, we need to focus on protecting the entire associated ecosystems where possible.

Coastal bluffs and mesas not only often have vernal pools and other related isolated habitats, they usually provide balance for the adjacent wetlands from an ecosystem point of view. Coastal sage provides gnatcatcher habitat which feed off insects in the wetlands and coastal bluffs and mesas often support raptors and owls which keep the rat populations under control, and rats are natural enemies of the ground nesting birds such as the least tern.

You can see these interactions between habitats of the coastal bluffs and mesas of Banning Ranch and the weltands habitats of Newport Salt Marsh, Semeniuk Slough, Talbert Marsh and related welands and riparian areas at the mouth of the Santa Ana River in the collective area we refer to as the Orange Coast River Park and adjacent land under consideration of open space acquisition like Banning Ranch (200 acres of wetlands + 200 acres of coastal bluffs and mesa)

Please make sure that your revised scope will offer protection to adjacent or bordering habitats that share an ecosystem with the wetlands and riparian areas in the your scoping for wetlands and Section 401 revisions.
