### **Public Notice of Draft Waste Discharge Requirements for Southern California Gas Company's TIMP Line 235 and Line 3000 El Dorado- Lugo-Mohave Alternating Current Pipeline Mitigation Project**

This public notice of draft Waste Discharge Requirements is provided in satisfaction of Water Code section 13167.5.

The State Water Resources Control Board (State Water Board) proposes to regulate the Southern California Gas (SoCalGas) Company's TIMP Line 235 and Line 3000 El Dorado-Lugo-Mohave Alternating Current Pipeline Mitigation Project (Project) pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.).

The Project will result in impacts to only waters of the state. The purpose of the Project is to install an alternating current mitigation system that will maintain the integrity and safety of SoCalGas' high-pressure natural gas transmission pipelines, L235 and L3000. The Project is necessitated by the Southern California Edison Eldorado-Lugo-Mohave (ELM) 500 kilovolt (kV) Series Capacitor project. The Project is required to maintain the integrity and safety of SoCalGas' existing infrastructure following construction and operation of the ELM Series Capacitor project.

**Staff will consider all comments submitted in writing to the State Water Board contact listed below and received during a 30-day comment period that begins (June 9 2025) and ends at 5:00 p.m. on the last day of the comment period (July 9, 2025).**
