

SETTLEMENT AGREEMENT AND RELEASE

This Settlement Agreement and Release (“Settlement Agreement”) is entered into by the People of the State of California, acting through the California Department of Justice, Office of the Attorney General (the “AGO”) and the California State Water Resources Control Board (the “SWRCB”) (collectively referred to as “California”); qui tam plaintiff American Cost Recovery Management, LLC (“ACRM”); and BP Products North America Inc. This Settlement Agreement shall be effective as of January 29, 2015 (the “Effective Date”). The entities entering into this Settlement Agreement are at times referred to individually as a “party” and collectively as the “Parties.”

I. RECITALS

A. WHEREAS, since the inception of the California Underground Storage Tank Cleanup Fund (the “Fund” or “UST Fund”) in 1989, BP Products North America Inc. and/or certain affiliates, including Atlantic Richfield Company; ARCO Petroleum Products Co.; ARCO Products Co.; BP Products North America, Assignee; and BP Oil Co., (collectively “BP”) submitted applications and certifications for partial reimbursement of expenses associated with BP’s cleanup of petroleum from leaking underground storage tanks (“USTs”) at properties throughout California (“UST Fund Claims”). A list of the UST Fund Claims the Parties presently have on record is attached to the Settlement Agreement as Attachment A. While the Parties believe this list to be comprehensive, if any UST Fund Claim pre-dating the Effective Date of this Settlement Agreement is later found to have been omitted, any such omission shall be considered inadvertent and the omitted UST Fund Claim shall be treated as though it were listed in Attachment A. For further clarification, the Parties’ intention in executing this Settlement Agreement is to include all UST Fund Claims within the scope of the settlement

release defined in Paragraph III, irrespective of whether the UST Fund Claim is enumerated in Attachment A.

B. WHEREAS, the UST Fund is operated under the direction of the SWRCB's Division of Financial Assistance.

C. WHEREAS, the Fund reviewed and deemed eligible numerous of BP's applications in accordance with Fund regulations and reimbursed BP for certain expenses associated with the cleanup of petroleum from leaking USTs at sites in California.

D. WHEREAS, on April 6, 2010, ACRM filed a complaint in Sacramento Superior Court, captioned *American Cost Recovery Management, LLC v. BP plc, et al.*, Case No. 34-2010-00074611 (the "Complaint"), that asserted a cause of action under the California False Claims Act for damages and civil penalties on behalf of the State of California.

E. WHEREAS, ACRM alleges that (i) when BP submitted applications and invoices for reimbursement to the Fund for its UST Fund Claims, BP failed to report or disclose to the Fund that BP had received proceeds from a series of insurance claims, litigation and settlements relating to cleanup of petroleum from leaking USTs at sites in California; (ii) BP's UST Fund Claims therefore were not eligible for reimbursements from the Fund; and (iii) BP should have repaid to the UST Fund the payments it received from the UST Fund for certain California UST sites.

F. WHEREAS, ACRM alleges that BP's failures to report or disclose to the Fund information regarding insurance claims, litigation and settlements constitute violations of the California False Claims Act and, therefore, BP is alleged to be liable for treble damages, penalties, attorneys' fees, costs, and interest to which California is entitled by law.

G. WHEREAS, following the filing of ACRM's Complaint, the AGO commenced an investigation into whether BP had received proceeds for expenses associated with the cleanup of petroleum from leaking USTs at sites in California from the following sources: (i) litigation filed against Atlantic Richfield Co. ("ARCO"), captioned *Pacific Indemnity Co. et al. v. Atlantic Richfield Co., et al.*, California Superior Court, Los Angeles County Case No. BC 196643; (ii) litigation between ARCO and its insurers, captioned *ARCO et al. v. Aetna Casualty & Surety Co. et al.*, Los Angeles County Case No. BC 015575; (iii) litigation filed by Amoco Oil Co. against its insurers, captioned *Amoco Oil Co. et al. v. Lloyd's of London et al.*, Circuit Court of Cook County, Illinois Case No. 1993-L-008484; (iv) settlement by BP America Inc. and Standard Oil of Ohio with their insurers in the late 1990's and early 2000's; (v) claims for corrective action of environmental remediation costs made on policies issued to third-party dealers and operators of BP's petroleum marketing facilities in California where such dealers and/or operators had a contractual obligation to purchase and maintain insurance to cover both the third-party dealer or operator and BP (as an additional insured); (vi) claims made on environmental liability policies held by BP; and (vii) claims made on policies held by BP that were issued by BP's captive or mutual insurers. Collectively, the series of past claims, litigation and settlements enumerated in this paragraph is hereinafter referred to as the "Coverage Matters."

H. WHEREAS, separate and apart from the civil liabilities alleged in the Complaint, pursuant to the UST Fund Regulations (Chapter 18 (commencing with section 2803), Division 3, Title 23, of the California Code of Regulations), the SWRCB has asserted that it may pursue an administrative action against a UST Fund claimant to revoke claims, disqualify claims from further participation in the Fund, and recover costs reimbursed to a claimant, where the SWRCB

determines that the claimant made a misrepresentation in statements, documents, or certifications contained in or accompanying a claim submitted by the claimant to the Fund.

I. WHEREAS, BP expressly denies it is liable for any of the claims asserted in the Complaint, by the AGO, or the SWRCB. BP further denies it received any money in the Coverage Matters for costs associated with the environmental remediation of UST leaks at service stations, with the exception of those associated with service stations listed in the *Pacific Indemnity Co. et al. v. Atlantic Richfield Co.* declaratory judgment suit.

J. WHEREAS, BP also denies that BP plc, BP America Inc. and BP West Coast Products LLC are properly named defendants for the allegations in the Complaint.

K. WHEREAS, recognizing that California, BP, and ACRM have a shared interest in the effective administration of the California UST Fund, and seeking to avoid the antagonism, uncertainty, inconvenience and expense of litigation and administrative proceedings, and in reliance on the representations contained herein and in consideration of the mutual promises, covenants, and obligations stated herein, the Parties agree as follows:

II. COURT APPROVAL, PAYMENT OF SETTLEMENT CONSIDERATION AND ADMINISTRATIVE SETTLEMENT

A. The AGO and ACRM shall apply to the court for approval of this Settlement Agreement. They will exercise their best efforts to obtain court approval and a finding that the settlement is appropriate, taking into account the best interests of the Parties involved and the public purposes behind the act under Government Code section 12652, subd. (c)(1).

B. Within 15 days of an order by the court approving the Settlement Agreement, BP shall pay an aggregate of seven million, nine hundred thousand dollars (\$7,900,000) (the "Settlement Amount"), to be allocated (as directed by California) as follows:

1. To the AGO, \$2,607,000, directed to the California Attorney General's Litigation

The Attorney General's Office will then forward \$3,910,500 to the California
UST Cleanup Fund.

3. To ACRM, \$1,382,500, as qui tam share pursuant to Government Code section
12652, subd. (g)(2). Payment to ACRM shall be directed to: [REDACTED]

C. Within 15 days of an order by the court dismissing the Complaint with prejudice, pursuant to Government Code section 12652, subd. (g)(8), BP shall pay counsel for ACRM the sum of \$250,000 directed to: Beneficiary Bank: ABA # [REDACTED]

[REDACTED] for final credit to: Wiggins Childs Quinn & Pantazis, LLC General Trust Account, Account [REDACTED] which sum covers ACRM's reasonable and necessary expenses, costs and attorneys' fees.

D. If the court enters a final order declining to approve this Settlement Agreement, the Settlement Agreement shall remain binding upon the Parties until the Parties have exhausted their appellate rights or the time to appeal or move for reconsideration expires. The Settlement Agreement shall become null and void once the Parties have exhausted their appellate rights regarding the court's order declining to approve the Settlement Agreement or upon expiration of the Parties' time to appeal or move for reconsideration of the court's order declining to approve the Settlement Agreement.

E. Within 10 days of payment by BP described in paragraph B above, the AGO and ACRM shall apply to the court for dismissal of the Complaint with prejudice.

F. Administrative Settlement

1. BP shall withdraw from the UST Fund 90 claims which were the subject of the *Pacific Indemnity Co. et al. v. Atlantic Richfield Co.* declaratory judgment suit, as identified in Attachment B. Within 10 days of an order by the court approving the Settlement Agreement, BP shall transmit to the UST Fund a Letter of Withdrawal pertaining to all of the claims listed on Attachment B. The claims in Attachment

B are permanently barred from further participation in the Fund. BP agrees never to resubmit for Fund reimbursement any of the UST Fund Claims identified in Attachment B, and never to assign any such claims to a third party for submission. However, nothing in this paragraph shall be construed to bar any third party from submitting in the ordinary course UST Fund Claims for UST releases, discovered or occurring after the effective date of the Settlement Agreement, including at any site associated with any claim identified in Attachment B.

2. The 153 UST Fund Claims identified on Attachment C, and which were the subject of the *Pacific Indemnity Co. et al. v. Atlantic Richfield Co.* declaratory judgment suit, may be eligible for further participation in the Fund. For clarification, the Fund shall not deem any claims ineligible on account of (i) any actual or alleged failure by BP to disclose to the UST Fund, in connection with any UST Fund Claim, facts regarding insurance coverage or the Coverage Matters; or (ii) past receipt (*i.e.*, receipt that occurred prior to the date of this Settlement Agreement) by BP of payments from insurers in connection with the Coverage Matters, resulting in a potential “double recovery” for UST Fund Claims. For reimbursement requests submitted for the UST Fund Claims listed on Attachment C, the UST Fund shall apply a \$25,400 offset, in addition to the deductible BP is required to pay under Cal. Code Regs., tit. 23 § 2808.1, subd. (a)(1), to otherwise eligible costs. This additional \$25,400 offset shall not apply to (i) UST Fund Claims submitted by any entity affiliated with Tesoro Corporation with respect to UST releases discovered or occurring after the Effective Date of this Settlement Agreement, including at any site identified in

Attachment C, or (ii) any UST Fund Claims BP submits in the ordinary course for future UST releases, discovered or occurring after the effective date of the Settlement Agreement, including at any site associated with any claim identified in Attachment C.

3. BP represents that it does not intend to assign to Tesoro or any other third party, prior to receiving a Letter of Commitment, any UST Fund Claim listed on Attachment C arising from a petroleum release that occurred on or before the Effective Date of this Settlement Agreement. In the event BP does assign to Tesoro any UST Fund Claim listed on Exhibit C, the \$25,400 offset described in the preceding paragraph shall still apply to that UST Fund Claim.

III. RELEASE AND COVENANT NOT TO SUE

In consideration for the payments and administrative settlement required by this Settlement Agreement and for the Recitals set forth in this Settlement Agreement, the Parties enter into a release and covenant not to sue, as follows:

A. Consideration; Scope of Release

1. For purposes of this Release, BP shall include BP Products North America Inc. and its affiliates BP plc, BP America Inc. and BP West Coast Products LLC, which are named in the Complaint, as well as affiliates that submitted UST Fund Claims as Atlantic Richfield Company; ARCO Petroleum Products Co.; ARCO Products Co.; BP Products North America, Assignee; or BP Oil Co. A list of the UST Fund Claims the Parties presently have on record is attached to the Settlement Agreement as Attachment A. While the Parties believe this list to be comprehensive, if any UST Fund Claim pre-dating the Effective Date of this

Settlement Agreement is later found to have been omitted, any such omission shall be considered inadvertent and the omitted UST Fund Claim shall be treated as though it were listed in Attachment A. For further clarification, the Parties' intention in executing this Settlement Agreement is to include all UST Fund Claims within the scope of the settlement release defined in this Section, irrespective of whether the UST Fund Claim is enumerated in Attachment A.

2. California and ACRM specifically release, discharge, and covenant not to sue BP with respect to the cause of action asserted in the Complaint.
3. ACRM, the SWRCB, and the AGO specifically release, discharge, and covenant not to sue BP or BP's agents and contractors, Pinnacle Environmental Management Support and Antea Group (formerly known as Delta Consultants), with respect to any claims or causes of action that were brought or could have been brought by ACRM, the SWRCB, or the AGO pursuant to the California False Claims Act, Government Code section 12650, et seq., or any other statutory or common law cause of action (including, without limitation, causes of action for fraud, unjust enrichment, or violations of California's Unfair Competition law), or to pursue any administrative remedies (including, without limitation, recovery of payments made by the Fund to BP or revocation, suspension, barring, or disqualification of pending claims to the Fund), relating to (i) any failure by BP to disclose to the UST Fund, in connection with any UST Fund Claim, facts regarding any insurance policies or insurance coverage; (ii) alleged misrepresentations or omissions of facts, in connection with any UST Fund Claim, regarding the Coverage Matters; or (iii) past receipt (*i.e.*, receipt that

occurred prior to the date of this Settlement Agreement) by BP of payments from insurers in connection with the Coverage Matters, resulting in a potential “double recovery” for UST Fund Claims. This Settlement Agreement does not release BP from any past, current or future obligation to take any corrective action as required by California law, or to submit documents, statements, or certifications as customary and necessary for the Fund to process for reimbursement any pending UST Fund Claims.

B. Nothing in this Settlement Agreement shall constitute or be construed as a satisfaction or release from liability for any conditions, obligations, or claims arising as a result of past, current, or future acts or omissions by BP that are unrelated to matters covered by the Complaint or do not otherwise fall within the Scope of Release described in paragraph III.A.

C. This Settlement Agreement shall not be construed to preclude any California State agency, department, board or entity from exercising its authority under any law, statute or regulation as against any Released Party with respect to matters outside the Scope of Release described in paragraph III.A.

D. This Settlement Agreement shall not serve to excuse or release any party from liability for any future act or omission.

IV. GENERAL

A. The settlement of this action is conditioned on approval by the Attorney General of California, which approval was given on March 20, 2014.

B. This Settlement Agreement constitutes the entire agreement and understanding between the Parties relating to the settlement of the Complaint. This Settlement Agreement may be modified or amended only by a writing signed by the Parties.

C. Nothing in this Settlement Agreement shall be construed as an acknowledgement or admission of liability by any party.

D. ACRM and SWRCB hereby mutually release and forever discharge each other and their respective agents from any and all matters, claims, complaints, charges, demands, damages, causes of action, debts, liabilities, controversies, judgments and suits of every kind and nature whatsoever, arising out of the same subject matter or occurrence relating to the Complaint and the Settlement Agreement.

E. ACRM and BP expressly waive as to each other their rights under California Civil Code section 1542, which states:

A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known to him or her must have materially affected his or her settlement with the debtor.

F. No term or condition of this Settlement Agreement shall be deemed to have been waived, nor shall there be an estoppel against the enforcement of any provision of this Settlement Agreement, except by written instrument signed by the party charged with the waiver or estoppel. No written waiver shall be deemed a continuing waiver unless specifically stated therein, and the written waiver of a term or condition as to a specific act or occurrence shall not operate as a waiver of any other term or condition or for any other or future act or occurrence.

G. This Settlement Agreement, and the rights, remedies, and obligations provided for hereunder, shall be construed and enforced in accordance with the laws of the State of California.

H. Sacramento County Superior Court shall retain jurisdiction to hear and determine California's motion to approve this Settlement Agreement, as set forth in paragraph II.A above, and to enforce this Settlement Agreement.

I. This Settlement Agreement shall be deemed to have been drafted equally by the Parties, and any rule of construction providing that ambiguity is construed against the drafting party shall be inapplicable in any dispute concerning the terms, meaning, or interpretation of this Settlement Agreement.

J. The Parties represent that they have read this Settlement Agreement, that its terms have been fully explained to them by their attorneys, and that they understand and agree with its terms.

K. Each signatory to this Settlement Agreement represents that he or she is fully authorized by the party he or she represents to enter into this Settlement Agreement, to execute it on behalf of the party represented, and to legally bind that party.




